S. No.	PARAMETERS	ELIGIBILITY CRITERIA
1.	Earnest Money Deposit along with Resolution Plan	Rs.10,00,000 (Ten Lakh) (Through Demand Draft or Bank Guarantee)
2.	Net Worth	Rs.5,00,00,000 (Five Crores) in case of individual bidder and in case of consortium/group of bidder Rs. 5,00,00,000 (Five Crores) of individual member of consortium/group.
3.	Minimum Upfront Payment as per Resolution Plan by the Resolution Applicant	25% of amount proposed
4.	Tenure of the Resolution Plan	2 Years
